Subject: Catalina Marketing Corporation (POS) Pending Merger

On Monday, August 13, 2007, the shareholders of Catalina Marketing Corporation (POS) voted to approve the proposed merger with Hellman & Friedman LLC. Pursuant to the merger terms each POS share will be converted into the right to receive \$32.50 cash. **The merger is anticipated to become effective on Monday, October 1, 2007.**

Pursuant to Options Clearing Corporation (OCC) By-Laws, all outstanding POS options will be adjusted as follows:

EFFECTIVE DATE: Option changes are expected to become effective on Tuesday, October 2, 2007
NEW DELIVERABLE: \$3,250.00 cash per contract (\$32.50 x 100)

Existing open interest in all POS options will remain until options are exercised or expire. Since they are American style options, they are exercisable at the option of the holder.
