Subject: A.G. Edwards, Inc. (AGE) Pending Merger With Wachovia Corporation (WB) *UPDATE*****

On Friday, September 28, 2007, the shareholders of A.G. Edwards, Inc. (AGE) will vote to approve the proposed merger with Wachovia Corporation (WB). Pursuant to the merger terms each AGE share will be converted into the right to receive 0.9844 WB Common Shares plus \$35.80 cash. Cash will be paid in lieu of fractional WB shares. **The merger is anticipated to become effective at 12:01 a.m. on Monday, October 1, 2007.**

Pursuant to Options Clearing Corporation (OCC) By-Laws, all outstanding AGE options will be adjusted as follows:

EFFECTIVE DATE: Option changes are expected to become effective on Monday, October 1, 2007
SYMBOL(s): AGE/OGR/YEG becomes AOU/OUE/LKP respectively
POS/EXERCISE LIMIT: 762,500 contracts until January 2009 expiration; where limits become 500,000 contracts until January 2010 expiration; where limits reverts to 250,000 contracts
MULTIPLIER: 100*(eg., Premium of 1.00 = \$100)
NEW DELIVERABLE: 1) 98 WB common shares.
 2) \$3,580.00 cash per contract (\$35.80 x 100)
 3) Cash in lieu of 0.44 fractional WB Shares
