Subject: ECI Telecom Corporation (ECIL/ECQ) Merger **EFFECTIVE**

On Wednesday, August 29, 2007, the shareholders of ECI Telecom Corporation (ECIL) voted to approve the proposed merger with Epsilon 1 Ltd & Epsilon 3 Ltd.. Pursuant to the merger terms each ECIL share will be converted into the right to receive \$10.00 cash. **The merger became effective on Friday, September 28, 2007.**

Pursuant to Options Clearing Corporation (OCC) By-Laws, all outstanding ECQ options will be adjusted as follows:

EFFECTIVE DATE: Monday, October 1, 2007
NEW DELIVERABLE: \$1,000.00 cash per contract (\$10.00 x 100)

Existing open interest in all ECQ options will remain until options are exercised or expire. Since they are American style options, they are exercisable at the option of the holder.
