# Best of NASDAQ Options B\*O\*N\*O Version 2.00

#### 1. Overview

The Best of NASDAQ Options<sup>SM</sup> (BONO<sup>SM</sup>) is a direct data feed product offered by NASDAQ<sup>®</sup> that features the following data elements:

- NASDAQ Best Bid and Offer Quotations: NASDAQ will calculate and disseminate its best bid and offer position, with aggregated size, based on displayable order interest in the <u>NASDAQ Options Market</u> system. For bandwidth efficiency reasons, NASDAQ will process bid quotation updates as a separate event from ask quote updates on the BONO data feed.
- NASDAQ Last Sale Data: NASDAQ will also disseminate trade messages for option order executions that occur within the NASDAQ Options Market via BONO.
- Administrative and market event messages including:
  - Trading action messages to inform market participants when a specific security is halted or released for trading on the NASDAQ Options Market.
  - Options Directory messages to be disseminated as part of its daily preopening process to relay basic option symbol and contract information for those securities traded on the NASDAQ Options Market.

#### 2. Architecture

The BONO feed will be made up of a series of sequenced messages. Each message is variable in length based on the message type and is composed of non-control ASCII bytes. The messages that make up the BONO protocol are typically delivered using a higher level protocol that takes care of sequencing and delivery guarantees.

NASDAQ plans to offer the BONO data feed in three protocol options:

### 3. Data Types

All numeric fields are represented in ASCII digits and are right-justified. Padding spaces appear on the left as necessary.

Prices are given in decimal format with 6 whole number places followed by 4 decimal digits. The whole number portion is padded on the left with spaces; the decimal portion is padded on the right with zeros. The decimal point is implied by position; it does not appear inside the price field.

Timestamp reflects the NASDAQ system time at which the outbound message was generated. NASDAQ states time as the number of milliseconds past midnight. The time zone is U.S. Eastern Time.

All alpha fields are left-justified. Padding spaces appear on the right as necessary.

#### 4. Message Formats

NASDAQ BONO will support four basic types of messages:

- o System Events
- o Administrative Data
- NASDAQ best bid and offer updates
- NASDAQ trade reports

Within the system event and administrative types, NASDAQ may support multiple message formats as outlined below.

#### 4.1. System Event Message

The system event message type is used to signal a market or data feed handler event. The format is as follows:

"N"	<i>Start of Normal Hours Closing Process</i> This message is intended to indicate that NASDAQ will no longer accept any new orders or changes to existing orders for options participating in the normal hours close process.

### 4.2. Options Directory Message

At the start of each trading day, NASDAQ disseminates directory messages for all symbols eligible for the auction process in the NASDAQ option system.

### 4.3. Trading Action Message

NASDAQ uses this administrative message to indicate the current trading status of an index or equity option within the NASDAQ Options Market.

Prior to the start of system hours, NASDAQ will send out a Trading Action spin. In the spin, NASDAQ will send out a Trading Action message with the "T" (Trading Resumption) for all options contracts that are eligible for trading at the start of the NASDAQ Options Market system hours. If a security is absent from the pre-opening Trading Action spin, firms should assume that the security is being treated as halted in the NASDAQ Options platform at the start of the system hours. Please note that securities may be halted in the NASDAQ system for regulatory or operational reasons.

After the start of system hours, NASDAQ will use the Trading Action message to relay changes in trading status for an individual security. Messages will be sent when a stock is halted, is released for quotation, or is released for trading.

### 4.4. Security Open Message:

NASDAQ plans to disseminate the Security Open Message for each security as soon as the opening / closing auction process is completed. Upon receipt of the open state message, firms should be advised that the option symbol denoted in the message is now available for auto execution within the NASDAQ Options Market system. Upon receipt of the closed state message, firms should be advised that the option symbol is no longer eligible for auto-execution within the NASDAQ Options Market system.

Please note that recipients should continue to process the Trading Action Spin message in order to determine if a contract is in a Halt state for the day. A security open message should <u>NOT</u> override the Trading action message indicating if an index or equity option is halted. Recipients should use both messages in tandem to indicate if the issue is halted and/or or open for auto execution.

## 4.5. NASDAQ Best Bid/Ask Updates

NASDAQ will continuously calculate its best bid and offer position for active options contracts on the NASDAQ Options Market during the trading day. Whenever the NASDAQ best bid or offer position changes, NASDAQ will send its best bid and offer update via the BONO data feed for the affected security. Please note that the BONO quote will reflect the highest price displayable in the NASDAQ system for buy orders and the lowest price displayable in the NASDAQ system for sell orders.

For bandwidth efficiency reasons, NASDAQ will treat the bid and ask updates as separate events. Upon receipt of a BONO update, the data feed recipient firm should adjust the quotation bid and/or ask only for the market side indicated in the message. If a market participant wishes to remove itself from one side of the market, NASDAQ will show the size field for the relevant market side as zero in this message format.

#### 4.6. BONO Trade Report

The BONO Trade Report message will be used to relay NASDAQ execution system transactions that are reported during the current business day. Please note that NASDAQ only reports one-side of a trade execution on the feed and other data feed products.

BONO Last Sale Messages should be included in NASDAQ time-and-sales displays as well as volume and other market statistics.

#### 4.7. BONO Broken Trade Report

The following message is used in the event that a NASDAQ options trade transaction is broken on the same business day that it is reported.
